

Town of Casco September Monthly Meeting

The monthly meeting for the Town of Casco was called to order by Chairman Joe Lukes at 7:00 pm on Tuesday, September 23. Present were Terry & Lois Vandermause, Amy & Todd Haverkorn, Daune & Vicki Sisel, Pat Benes, Joel Nellis, Nick Achtermeier, Andrew Gantmen, Tina Padgett, Luke Michalski and all members of the Casco Town Board.

The clerk read the minutes from the August meeting. A correction was made by Joe that the farmer would be responsible to pay the \$1500 fine and not the hauler. Barry made a motion to approve the corrected minutes and Perry seconded. Motion approved.

The treasurer reported as follows; Checking-5,696.02 Municipal Savings-254,934.70 Cemetery-122.73 Checking CD-55,721.68 Cemetery CD-4,255.42 Town 6-month CD-304,200.30 There were no deposits of interest. Perry made a motion to approve the report and Barry seconded. Motion approved.

Edie reported that McNulty Surveying corrected lot lines on the W. Slovan cemetery. Edie will bring the map to the county to have a deed made. Todd Haverkorn, Vicki Sisel and Joel Nellis all met with the plan commission to request a rezone of property lines. The plan commission unanimously approved the request. Perry made a motion to approve the rezone and Barry seconded. Motion carried.

Lois & Terry Vandermause met with the plan commission to rezone 2.67 acres of their property from A-1 Ag to A-2 Ag. This was unanimously approved. Barry made a motion to approve the rezone and Perry seconded. Motion carried. The clerk signed the CSM.

Joe reported on the Kozloski court hearing which was held on September 17. The court awarded the Town \$8,500 of the assessed fines. There will be another hearing in October for an ordinance violation caused by them living in a camper for which they pled not guilty.

The garbage and recycling contract with Harters has expired. Going Garbage and Harters both presented proposals to the Town. Going Garbage offered a cheaper rate and capped the CPI at 4.0 %. Perry questioned the process of starting over and Joe asked Harters if they could match the cap limit. They agreed to that. Barry made a motion to accept Harters proposal and Perry seconded. Motion carried. It will be a 5-year contract.

Joe talked to the DNR about replacing culverts on Birch Lane and Park Lane. He is waiting for bids. This would be a 50/50 cost split with the county.

There was a request by a citizen to lower the speed limit on Rockledge Rd from Apple Ct. to County C. It could be lowered 10 mph without doing a study.

A picnic license was requested for The Kewaunee County Dairy Promotion Committee to sell beer at Moo-toberfest on October 4. Barry made a motion to approve and Perry seconded. Motion carried.

Pat Benes asked about the jail roof and if ditch mowing is done.

Peggy again questioned why she is writing the checks instead of the clerk. She also stated that the 6-month CD is coming due October 24.

The next meeting is scheduled for October 20 at 7:00 pm. Barry made a motion to adjourn and Perry seconded. Meeting adjourned at 8:25 pm.
